


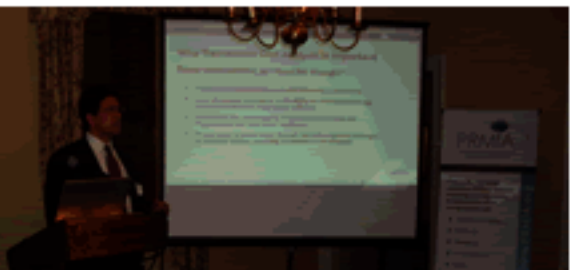
2ND HEDGE FUND RISK MANAGEMENT EVENT
